YELLOW-JACKET WATER CONSERVANCY DISTRICT PROPOSED BUDGET FOR 2015 SUBMITTED FOR BOARD REVIEW AND APPROVAL

The attached proposed budget is prepared for consideration by the Board of Directors of the Yellow Jacket Water Conservancy District ("District"). The primary funding source for the District comes from property tax revenues from Rio Blanco, Moffat, and Garfield Counties. The assessed value of property within the District remains relatively steady for 2016. This budget considers maintaining the District's present mill levy of 0.209 mills. This budget considers a slight decrease in revenues for 2016.

The District anticipates incurring additional engineering fees in 2016 as it works to develop its long term master plan for its water rights portfolio and expand upon previous studies for the feasibility of its water rights. This engineering analysis will continue to look at reservoir locations and feasibility based on the District's existing water rights portfolio.

The budgetary basis of accounting the District uses is cash basis.
